RELEASE AND INDEMNITY

In this agreement:

1. "CCC" means all or any of the Calgary Children's Choir Association (CCC), its Board of Directors, and its officers, directors, employees, consultants, delegates, volunteers and chaperones;

2. "Event" means an event sanctioned, sponsored or organized by the CCC for which I, the undersigned, have signed the "Permission to Participate" form issued by the CCC authorizing the Participant to participate in the event.

In consideration of the above named Participant being allowed to participate in an Event, I, the undersigned, being the parent or legal guardian of the Participant, recognizing that there may be an element of risk or injury arising from participation in an Event and arrangements related thereto, do hereby release the CCC Board of Directors, the Choir Director, Chaperones and Staff from any and all actions, suits, claims and demands whatsoever arising in connection with an Event, except when and to the extent that such losses or damages result from the competence or willful or wanton misconduct of the CCC.

If during an Event it becomes necessary in the judgment of the CCC for the Participant to receive medical or surgical treatment or attention, the CCC may, after having made reasonable efforts to contact me, authorize such treatment or attention by or as recommended or directed by a duly licensed physician. In such event, I do hereby release the CCC from any and all actions, suits, claims, and demands whatsoever which may arise as a result of the said treatment, or attention, and further indemnify and agree to hold harmless the CCC from any and all actions, suits, claims or demands whatsoever which may be brought as a result of such treatment or attention.

If the CCC in its sole judgment and discretion determines that disciplinary action is warranted against the Participant during an Event, the CCC may at any time prior to the end of such Event return the Participant to Calgary into my care by appropriate transportation including, without limitation, a commercial airline of the CCC's choice, in which case, I indemnify and agree to hold harmless the CCC for all expenses of such return, including airfare.

If the Participant causes any injury to the person or damage to the property of any other person during an Event or travel to and from such Event, I indemnify and agree to hold harmless the CCC from any damages, costs or expenses the CCC might incur or be ordered to pay as a result of such injury or damage.

Consent for Specific Media Coverage

Photographs are taken during various events that our choristers participate in such as camp, rehearsals, concerts, etc. We would like to use some of these photos on our website and in our brochures. Some of these photos would also be used on the Calgary Children's Choir social media sites. We need your permission to do so.

All or portions of the work referred to above will become part of the media organization's database and may be adapted for other educational or noneducational applications, productions, broadcast, rebroadcast, published, exhibited, reproduced, and/or distributed in various media formats to a number of markets.

The Calgary Children's Choir does recognize that there are instances where parents may not wish their children to be recorded. Similarly, for independent students or adults, we recognize that there may be instances where you do not wish to be recorded.
